LDUSBCWBA TOURNAMENT RULES

1. All bowlers must be LDUSBCWBA sanctioned to participate in this tournament. Bowlers must check in 30 minutes before schedule bowling time.
2. All entries must be made on official entry blanks, and all bowlers must use the name shown on the sanction card.
3. Entrants in Division 1 will receive handicap of 90% of 210 and of Division 2 will receive handicap 90% of 154. Entrants shall use her highest league average as of the end of the 2008-09 winter season, providing she bowled 21 games or more. The book average will be recognized as official. If she has no 2008-09 winter average, an entrant shall use the highest 08-09 summer league average, providing she bowled 21 games or more. An entrant without a 21 game average shall be permitted to bowl in the tournament using her highest current average of at least 12 games or more as of October 6, 2009 and must be verified by the league secretary. All others must bowl scratch. All entrants must use her highest league average, regardless of whether bowls as a regular or a substitute. USBC Rule 319a2 does not apply.
4. The LDUSBCWBA Board of Directors may refuse to permit any team or individual to bowl if it is determined that it was an illegal entry. If an illegal entry should be accepted through error, all fees paid on such entry shall be declared null and void. **No entry money will be returned after entries are closed.**
5. An entrant may participate in as many team events as time will allow, however, not more than two players on one team can place more than once in the prize list for position standings. Make up teams are allowed. Substitutes and women members from sanctioned mixed leagues are eligible. Scores bowled in the first team event will be used in computing the All Events total.
6. Bowlers in the Doubles event must also enter the Singles event. Bowlers entered in the Singles event must also enter the Doubles event. Substitutes must take the place of the bowlers they are replacing. No rearranging of partners will be permitted.
7. A bowler may enter and bowl only once in the Doubles & Singles events. Doubles being bowled first immediately the entrant present shall bowl her Singles event first. If her partner has not arrived by the time the Singles event is finished and substitute cannot be found, the entrant present shall be permitted to bowl her games in the Doubles event in order to qualify for All Events.
8. Substitutes are allowed when replacement is necessary. In case of emergency after a game has started, a substitute, if one is available, shall be allowed in the Team and Doubles event only. The combined scores are to count in either of these events. If no substitute is available, only the actual score of the frames bowled shall count.
9. A substitute will not be required to reimburse the original entrant with the entry fee paid nor shall the substitute be expected to give the original entrant any prize money or trophy she may win.
10. Positively no delays or postponements allowed. This rule will be strictly enforced.
11. Any player or team arriving after the game has started will be allowed to bowl and the score(s) will count beginning in the frame that is being bowled. **NO SCORE WILL BE GIVEN FOR FRAMES MISSED.**
12. Where the Tournament Chairperson deems it necessary (and it is possible to do so), entrants may be transferred to a different date, squad or pair of lanes.
13. In the event a team is unopposed on a pair of lanes, each frame shall be completed on one lane before the next frame is started on the adjoining lane. This rule shall apply to Doubles & Singles events also. **PACERS WILL NOT BE PERMITTED IN THIS TOURNAMENT.**
14. Any protest affecting eligibility or playing rules must be confirmed in writing to the tournament director before the tournament prize payments are made. Errors in scoring must be reported to the tournament director within 24 hours.
15. **ALL EVENTS FEES:** Bowlers entered in the four women, two women and individual events may participate in All Events prizes by paying \$2.00 per entrant prior to the advertised closing date of entries. Paid All Events are not transferable unless substitute replaces the original entrant in all three events and the tournament chairperson or her assistants prior to the time of the substitute's participation make the transfer in any event.
16. **Prize fund returned 100% in a ratio of 1 in 5.**
17. The Board of Directors of the LDUSBCWBA shall decide any questions not covered by these tournament rules.
18. The Board of Directors of the LDUSBCWBA shall have the power to hear and act on all protests arising from or under construction of the rules of the LDUSBCWBA.
19. The use of such substances as talcum powder, pumice, rosin, etc., on shoes or lanes is strictly prohibited.
20. LDUSBCWBA donating additional Prize Money upon receipt of 30 separate entries in the tournament.
21. LDUSBCWBA has the right to remove any bowler in violation of Rule 17B.

Only in case of equipment breakdown shall a tournament entrant be allowed to re-bowl a game or series.

*The entrants whose names appear hereon or their authorized replacements hereby agree that the LDUSBCWBA, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergencies or cause relating thereto or resulting there from, fires, strikes, lockouts, labor difficulties or other causes beyond the control of the LDUSBCWBA.
